Online Meeting Recap

Sussex Rural Electric Cooperative is an organization founded by and dedicated to supporting the needs of our members and our community. As a part of this commitment, each year we host an Annual Meeting where we have the opportunity to speak with members face-to-face, provide food and prizes, and to foster the Co-op's bond with its membership. Due to the unfortunate circumstances of the coronavirus pandemic, we were unable to host a meeting last year. We instead shifted our focus to 2021, but even then it was unclear where the state of New Jersey would be in a year's time. During this planning stage in late winter/early spring, our board of directors reached the decision that Sussex Rural Electric Cooperative would have to cancel its Annual Meeting once again. As a member-owned electric utility, our members have the opportunity to run and vote for the board of directors during each year's election, which we have conducted by mail since 2014.

This year's election was uncontested, with Tom Madsen from District 1, Ron Dupont from District 2, and Barbara Berge-Miller from District 3 each achieving re-election. Congratulations to these three members of our board who will continue to dutifully serve our members!

Scholarship Awards

Alongside the release of our Online Meeting, we formally announced our scholarship awards for the year. These students from the class of 2021 have had to put up with disruptions in regular schedules and shifts between online and in-person learning, so this year we are especially proud of the achievements of our scholarship recipients. Our Scholarship in Memory of James Howard Goodwin was awarded to two students from High Point Regional High School - Olivia Dunn and Kassie Britt. Our Trade School/Certification Scholarship, which we introduced in 2019 to specifically support the growth of the trades in our community, was awarded to Reiss Little and William Bassett, both students at Sussex County Technical School. Messages from Legislators

This will be a short note in the overall recap of our Online Meeting, but I feel it would be unfair not to spotlight the messages provided by Congressman Josh Gottheimer and Senator Steve Oroho for our Online Meeting. We often host representatives of our area or staffers from their offices at our Annual Meetings, and it was wonderful that these two were able to provide encouraging and supportive messages to the Co-op and our members. Thanks to you both!

Financials, Chairman's Address, and Q&A

Board Secretary/Treasurer Ray Cordts gave an address on the Co-op's financial standing. A more detailed look at our finances is of course available in our 2021 Annual Report, which was sent out to members in May's issue of Currents. Meanwhile, Chairman of the Board Jack Haggerty delivered his own address in another video, touching on SREC's current role in the energy market and what the near future may look like for us.

We also released a video where I answered some questions submitted by members who had registered online for our prize drawing. I had the opportunity to go into detail on topics that include renewable energy, if and how our grid connects with JCP&L's, and establishment of a time-of-use rate for electric vehicle charging. If you've been wondering about any of these matters, I highly encourage you to take a look at this Q&A video for more information. Eves on the Prize

While an Online Meeting could never fully capture all of the value of an in-person meeting, we felt it was important to reward our members' interest with the opportunity to enter a prize drawing, much like we do for the in-person Annual Meetings. This year, members who voted in our board election or registered online were entered into the prize drawing, with 49 prizes available. Those who did both earned two chances to win. This year's grand prize was a free year's worth of electricity, valued at \$1,250 based on average annual usage of a residential member.

We randomly chose our 49 winners from our list of voters and registrants and made formal announcement of winners on our site.
